Draft Environmental Impact Statement (DEIS)

- Project Location:** The Proposed Action would expand the existing 6.4-mile Metro Rail light-rail transit from its current terminus at University Station on the University at Buffalo South Campus, along Kenmore Avenue, Niagara Falls Boulevard, Maple Road, and Sweet Home Road, through the UB North Campus to John James Audubon Parkway and Interstate 990. Ten stations are proposed as part of the 7-mile extension with two stations containing a park & ride facility—and a light maintenance/storage facility is proposed at the end of the line.
